It deals with our AOC Consent 9 Order and contracts we had --10 MR. GENITEMPO: AOC related to? 11 COMMISSIONER DeVITA: Reservoir covers. 12 MR. 
COMMISSIONER DeVITA: Why? 1 PRESIDENT KOLODZIEJ: Because we have to 2 have a full complement here. We're down two 3 people today. We're down two people today. 4 MR. GENITEMPO: Can I interject just for 6 safety? I think unless your discussion is going to 7 revolve around potential litigation in that way, 8 we'll bring in some type of Order to Show Cause, I 9 don't think it would be appropriate to discuss it, 10 regardless of who is here or not here. GENITEMPO: If that's your question 19 about whether we can take legal action, I would 20 say we can discuss it here. If your question is 21 what should we do logistically, public notice 22 wise, contacting them, I would say it's not 23 something we can discuss. 24

20	makes us look good. I don't know about you am
21	allowed to talk about this here?
22	MR. GENITEMPO: No.
23	PRESIDENT KOLODZIEJ: No. Okay.
24	See, it's a good thing you're here.
25	COMMISSIONER LEVINE: It would be letter

to talk about it in the public meeting. PRESIDENT KOLODZIEJ: No, no. We can't. This is a closed session. MR.
