1 Sanchez and Commissioner Cleaves are absent). 2 MR. AMODIO: Next, we have a Resolution 3 from Mr. Weiss. 5 COMMISSIONER BAZIAN: If I may, Mr. 6 President. We didn't do committee reports. This 7 was discussed at finance. The purpose of this 8 Resolution is to give our CFO the authority to 9 basically place these funds in safe investments, minimum grade level A, as I recall, so at least we 10 11 can earn a little bit more, we can have a little 12 bit more cash for our projects. We did ask about tax implications. We 13 14 were told that there are no tax implications. I 15 was also told that this is something that we've 16 been trying to get done for how long, Yitz? 17 MR. WEISS: Years. 18 PRESIDENT PRO TEM LEVINE: Who is going to 19 review it? Is anybody going to know where the 20 funds are --21 COMMISSIONER KOLODZIEJ: It comes back to 22 finance. 23 COMMISSIONER BAZIAN: Finance. 24 PRESIDENT PRO TEM LEVINE: So before he 2.5 puts it in, finance will review?

1	COMMISSIONER BAZIAN: No. The Resolution
2	specifically gives him the authorization to do so
3	without coming back to us. But it gives him
4	specific guidelines. It's got to be short term;
5	maximum one year. It's got to be one year or less
6	in terms of the duration. And it's got to be from
7	an organization that's at a minimum leveled issue
8	rating of A or better. And it actually says for a
9	period of not more than 397 days.
10	MR. WEISS: Right. We're limited by our
11	bond Resolution for one year.
12	COMMISSIONER BAZIAN: Why does it say 397?
13	MR. WEISS: Should the bond resolution
14	ever be changed, legally, we're allowed to
15	COMMISSIONER BAZIAN: Okay. Fine. That's
16	the purpose.
17	MR. AMODIO: Any other questions?
18	MR. HANLEY: This was reviewed by bond
19	counsel?
20	MR. WEISS: Yes. This was suggested by
21	bond counsel.
22	MR. HANLEY: Okay. Good.
23	MR. AMODIO: Any further questions?
24	Motion.
25	COMMISSIONER KOLODZIEJ: So moved.
