WHEREAS, PVWC awarded Award Contract No. 22-B-16 entitled "Replacement of Hydrants" (the "Contract") to Roman E & G Corporation of Newark, New Jersey at PVWC's Commission Meeting on July 27, 2022 (PVWC Resolution 22-080), not to exceed \$9,681,030.00 and with said Contract expiring on July 26, 2024; and

WHEREAS, Proposed Change Order No. 1 is required to support PVWC's Distribution Department to conduct all hydrant and valve inspections in advanced of the hydrant replacement work, with the cost proposal attached hereto as **Exhibit A**, with a total increase of \$554,430.00 (6% increase) for 1,000 locations which brings the total adjusted Contract Price up to \$10,235,460.00; and

WHEREAS, PVWC's Chief Financial Officer has certified, with respect hereto, that funds are currently available for said purpose and a copy of the said certification is attached hereto and made a part hereof as **Exhibit B**.

NOW, THEREFORE, BE IT RESOLVED, by Passaic Valley Water Commission, in the County of Passaic, New Jersey:

- That PVWC hereby approves Change Order No. 1 and awards the changes to the scope of Work as set forth hereinabove; and
- 2. That the appropriate officials of PVWC, and such other officers, employees and officials of PVWC, on behalf of PVWC, are hereby authorized to execute and enter into the said Amendment to the Agreement, and to perform such other acts and execute such documents

- as are necessary to implement the terms and intentions of this Resolution; and
- 3. That this matter shall be advertised as required by New Jersey law, in accordance with an appropriate form of notice, and a copy of this Resolution shall be placed on file and made available for inspection at the office of the Administrative Secretary of Passaic Valley Water Commission.
