RESOLUTION TO PROCURE GOODS AND SERVICES
FOR A REVERSE 911 SYSTEM

DATE OF ADOPTION: MARCH 22, 2023

WHEREAS, Passaic Valley Water Commission ("PVWC") seeks to procure a Reverse 911 System; and

WHEREAS, Rave Mobile Safety Reverse 911 System will allow PVWC to transmit geo-targeted messages and notifications, via phone, text and/or email messages to enhance the services that PVWC provides to its customers in the way of dissemination of information and providing safety messages in order to protect the public health, safety or welfare of its customers; and

WHEREAS, PVWC has elected to procure the above-referenced services from Rave Mobile Safety of Framingham, Massachusetts (the "Awardee"), in the amount of \$31,500.00 for a period of two (2) years for an annual rate of \$15,750.00, a copy of the quotation is attached hereto as **Exhibit A**; and

WHEREAS, PVWC has utilized the service of Rave Mobile Safety since 2021 to provide reverse 911 services and it is in the best interest of PVWC, its customers and constituent municipalities for PVWC to continue to provide these services to its customers; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(a)(i) requires that notice, with respect to professional services awarded without competitive bids, must be publicly advertised; and

WHEREAS, the services to be rendered pursuant hereto constitute professional services within the meaning and intent of the Local Public Contracts Law; and

WHEREAS, PVWC's Chief Financial Officer has certified, with respect hereto, that funds are currently available for said purpose and a copy of the said certification is attached hereto and made a part hereof as **Exhibit B**.

NOW, THEREFORE, BE IT RESOLVED, by Passaic Valley Water Commission, in the County of Passaic, New Jersey:


1. That procurement of Rave Mobile Safety Reverse 911 System for the two (2) year period, in the total amount set forth hereinabove in connection with the above described goods and services is hereby authorized and approved; and
2. That officers, employees and officials of PVWC are hereby authorized to perform such acts and execute such documents as are necessary to implement the terms and intentions of this Resolution; and
3. That this matter shall be advertised as required by New Jersey law, in accordance with an appropriate form of notice, and a copy of this Resolution shall be placed on file and made available for public inspection at the office of the Administrative Secretary of Passaic Valley Water Commission.


