RESOLUTION OF PASSAIC VALLEY WATER COMMISSION

**RESOLUTION REQUESTING AUTHORITY TO REJECT THE BID FOR** CONTRACT NO. 23-V-10 - LIQUID OXYGEN, AND COMMENCE **NEGOTIATIONS** 

**DATE OF ADOPTION: MARCH 22, 2023**

WHEREAS, on or about January 18, 2021, the Passaic Valley Water Commission ("PVWC") entered into a two-year contract with Airgas USA, LLC to supply liquid oxygen to the Little Falls Water Treatment Plant; and

WHEREAS, before that contract was set to expire, the PVWC solicited bids for a new contract to supply liquid oxygen, with a bid opening date of December 22, 2022, resulting in no responsible bids received; and

WHEREAS, on February 3, 2023 the PVWC re-solicited bids for liquid oxygen (Contract No. 23-V-10 "Liquid Oxygen") with a bid opening date of March 7, 2023 using substantially similar terms and conditions to the first bid; and

WHEREAS, the PVWC received a bid from its current vendor, Airgas USA, LLC, in response to the re-bid, however, upon the review by the Executive Director, Director of Engineering, Director of Purchasing, (and Counsel as to form and legality), the bid submitted by Airgas was found to contain defects due to Airgas' insertion of material qualifications and exceptions in blackline to the Bidding Documents it included with its Bid Submission, which defects might not be waivable by the PVWC or curable by AirGas; and

WHEREAS, the bid instructions also provided that the PVWC reserves the right to reject all bids if only one bid is received, which provides an addition ground to reject all bids in this case; and

**WHEREAS,** it is recommended that the Commission resolve to reject the lone bid by AirGas in response to Contract No. 23-V-10 "Liquid Oxygen" immediately; and

WHEREAS, it is further recommended that the Commissioners resolve to authorize PVWC Officers to take one of two steps, either rebid a second time or negotiate in lieu of bidding under N.J.S.A. § 40A:11-5(3); and

**WHEREAS,** when the PVWC solicits bids on two occasions and no bids are received, the PVWC has the option to negotiate a contract for goods and/or services with any of the bidders or any other vendor of its choosing in lieu of further public bidding provided that it follows the conditions set forth in the Local Public Contracts Law, N.J.S.A. § 40A:11-5(3);

WHEREAS, Liquid Oxygen is an essential component of PVWC's treatment process for production and delivery of clean disinfected drinking water to PVWC's consumers and customers, therefore, securing a contract as soon as possible with a vendor committed to supply this essential element to the PVWC under an agreement would be in the PVWC's best interest;

WHEREAS, the Commissioners of PVWC have considered the recommendations of PVWC's Executive Director, Chief Financial Officer, Director of Engineering, and Director of Purchasing (and PVWC's General Counsel as to form and legality) and have determined that it is appropriate and in the best interest of PVWC, its users and constituent municipalities, to adopt same as its act;

WHEREAS, the PVWC may not select the option of negotiation in lieu of further public bidding under N.J.S.A. § 40A:11-5(3) unless the Commissioners adopt a resolution authorizing this option by two-thirds affirmative vote;

WHEREAS, the Commissioners of PVWC have considered the recommendations of PVWC's Executive Director, Chief Financial Officer, Director of Engineering, and Director of Purchasing (and PVWC's General Counsel as to form and

legality) and have determined that it is appropriate and in the best interest of PVWC, its users and constituent municipalities, to adopt same as its act;

**NOW, THEREFORE, BE IT RESOLVED,** by Passaic Valley Water Commission, in the County of Passaic, New Jersey:

1. That appropriate officials and employees of the PVWC be and are hereby directed to proceed with either re-bidding for liquid oxygen supply or engaging vendors of liquid oxygen in negotiation in lieu of further public bidding pursuant to N.J.S.A. § 40A:11-5(3), in accordance with these findings and applicable law, and to perform such acts and execute such documents as are necessary to implement the terms and intentions of this Resolution as set forth hereinabove.
