**RESOLUTION OF PASSAIC VALLEY WATER COMMISSION**

**RESOLUTION FOR ADOPTING POLICY TO CONTROL INGRESS AND  
EGRESS OF VEHICLES AT LEVINE RESERVOIR PROPERTY DURING  
CONSTRUCTION ACTIVITIES OF WATER STORAGE IMPROVEMENTS  
PHASE 1 - LEVINE WATER TANKS**

**WHEREAS**, the County of Passaic is requiring the Passaic Valley Water Commission ("PVWC" or "Commission") to adopt a formal policy to control the ingress and egress of vehicles at the Commission's Levine Reservoir property during construction of the Levine Water Storage Tanks ("Project") to enhance traffic safety within the county roadway at the intersection of Grand Street and Reservoir Avenue, Paterson, County of Passaic, New Jersey; and

**WHEREAS**, Passaic County will allow the Commission to maintain current intersection configuration during construction as a condition of obtaining approval for Project if said policy is adopted by PVWC; and

**WHEREAS**, a flagger shall be utilized for safety and control of vehicles requiring ingress and egress from the site driveway adjacent to the Grand Street and Reservoir Avenue intersection during construction of Project; and

**WHEREAS**, flagging procedures shall be in accordance with the MUTCD (Section 6E) and NJDOT's work zone safety set-up guide, is intended only to manage conflict points along Reservoir Avenue and shall not supersede the signalized operation at the intersection itself; and

**WHEREAS**, it is in the best interests of PVWC to adopt said policy to enhance traffic safety during construction of said Project; and

**WHEREAS,** a copy of the Director of Engineering's memorandum dated April 19, 2023 is attached hereto and made a part hereof as **Exhibit A**; and

**NOW, THEREFORE BE IT RESOLVED,** by Passaic Valley Water Commission, in the County of Passaic, New Jersey:

1. That PVWC shall adopt policy during construction of Project as described hereinabove.
2. That the appropriate officers and employees of PVWC are hereby authorized to perform such acts and execute such documents as are consistent herewith, in order to implement the terms and intent of this Resolution as set forth hereinabove.
