AMENDMENT TO CONTRACT NO. 21-V-13 ENTITLED "LIQUID SODIUM HYDROXIDE"

WHEREAS, on January 6, 2022, four (4) bids were received by the Passaic Valley Water Commission ("PVWC") for Contract No. 21-V-13, (the "Contract") entitled "Liquid Sodium Hydroxide;" and

WHEREAS, PVWC approved the award of the Contract on January 19, 2022 to Univar Solutions USA, Inc. of Morrisville, Pennsylvania for a period of Seven Hundred and Thirty (730) Days or Two (2) Years; and

WHEREAS, due to significant price increases in the market, Univar advised that they were no longer able to supply Liquid Sodium Hydroxide to PVWC at the contract price and requested a price increase to ensure no disruption in the delivery of Liquid Sodium Hydroxide; and

WHEREAS, PVWC conducted due diligence and market research with respect to the price of for Liquid Sodium Hydroxide in the market; and

WHEREAS, PVWC has determined that it would be fair to raise the contract price from \$2.1321 per gallon to \$2.45 per gallon for the remainder of the Contract; and

WHEREAS, it is PVWC's intention to go back out to bid in January 2024.

NOW, THEREFORE, BE IT RESOLVED, by Passaic Valley Water

Commission, in the County of Passaic, New Jersey:

- 1. That PVWC shall agree to a price increase of \$2.1321 per gallon to \$2.45 per gallon for the remainder of the Contract.
- 2. That appropriate officials and employees of the PVWC be and are hereby directed to perform such acts and execute such documents as are necessary to implement the terms and intentions of this Resolution as set forth hereinabove.
