RESOLUTION FOR BUDGET AMENDMENT, CHANGE ORDER NO. 1 AND CONTRACT EXTENSION FOR PROJECT NO. 21-P-40, "PROFESSIONAL SERVICES FOR WATER

QUALITY & ACCOUNTABILITY ACT (WQAA) COMPLIANCE" WITH CREW **ENGINEERS, INC.**

WHEREAS, Contract No. 21-P-40 entitled "Professional Services for Water Quality &

Accountability Act (WQAA) Compliance" (the "Project") was awarded to Crew Engineers, Inc.

("Crew") of Butler, New Jersey (the "Awardee") at PVWC's Commission Meeting dated July

27, 2022 (PVWC Resolution 22-073) in accordance with the authorized scope of work, and

with reimbursement to be on a time-and-materials basis, not to exceed \$150,000.00; and

WHEREAS, PVWC directed Crew to assist the Commission with developing an Asset

Management Plan in accordance with the requirements of the Water Quality Accountability

Act which includes identifying all encroachment, accessibility and overgrowth issues along

PVWC's transmission mains, developing Pipe Criticality and Quality of Service mapping and

writing the required Asset Management Plan reports in accordance to the AWWA guideline for

PVWC's Main System, Lodi and North Arlington; and

WHEREAS, it is recommended that PVWC provides Crew with a time extension to

December 31, 2023 to allow completion of outstanding work; and

WHEREAS, Proposed Change Order No. 1 will reimburse Crew for all work projected

to be completed up to the new expiration date of said contract and increases the total adjusted

Contract Price by an additional \$25,000.00 which brings the total adjusted Contract Price to

\$175,000.00; and

WHEREAS, the Director of Engineering has reviewed Crew's Proposal and found it to

be reasonable, considering the nature and scope of additional Work involved, and has

recommended that the said changes to the Project, and additional costs related thereto, be

approved; and

WHEREAS, the said changes will be incorporated into an Amendment to Agreement

for the Project, the form of which is also attached hereto and made a part hereof as Exhibit

A; and

WHEREAS, the additional services to be rendered pursuant hereto constitute

professional services (or extraordinary unspecifiable services) within the meaning and intent

of the Local Public Contracts Law; and

WHEREAS, PVWC's Chief Financial Officer has certified, with respect hereto, that funds are currently available for said purpose and a copy of the said certification is attached hereto and made a part hereof as **Exhibit B**.

NOW, THEREFORE, BE IT RESOLVED, by Passaic Valley Water Commission, in the County of Passaic, New Jersey;

- That PVWC hereby approves Change Order No. 1 and time extension to the terms as set forth hereinabove; and
- 2. That the appropriate officials of PVWC, and such other officers, employees and officials of PVWC, on behalf of PVWC, are hereby authorized to execute and enter into the said extension to the Agreement, and to perform such other acts and execute such documents as are necessary to implement the terms and intentions of this Resolution; and
- 3. That this matter shall be advertised as required by New Jersey law, in accordance with an appropriate form of notice, and a copy of this Resolution and Agreement shall be placed on file and made available for inspection at the office of the Administrative Secretary of Passaic Valley Water Commission.

THIS AMENDMENT TO AGREEMENT (hereinafter "AMENDMENT") made as of _______, 20___ between PASSAIC VALLEY WATER COMMISSION ("PVWC"), a Public Utility Company organized pursuant to its enabling statute (N.J.S.A. 40:62-108 et seq.), having its principal place of business at 1525 Main Avenue, Clifton, New Jersey 07011, and Crew Engineers, Inc., a professional firm (hereinafter "PROFESSIONAL" and/or "contractor") having a place of business at 1250 Route 23 North, Butler, New Jersey 07405.

WHEREAS, this AMENDMENT hereby modifies the original signed and executed agreement (the "AGREEMENT") with PVWC and PROFESSIONAL who was awarded Project 21-P-40 entitled "Professional Services for Water Quality & Accountability Act (WQAA) Compliance" (hereinafter the "PROJECT") at PVWC's Commission Meeting dated July 27, 2022 (PVWC Resolution 22-073); and
