RESOLUTION OF PASSAIC VALLEY WATER COMMISSION

RESOLUTION FOR BUDGET AMENDMENT, CHANGE ORDER NO. 1 AND CONTRACT EXTENSION FOR PROJECT NO. 21-P-47, "PROFESSIONAL SERVICES FOR GIS SOFTWARE MANAGEMENT" WITH MOTT MACDONALD. LLC

WHEREAS, Contract No. 21-P-47 entitled "Professional Services for GIS Software Management" (the "Project") was awarded to Mott MacDonald, LLC. ("Mott") of Iselin, New Jersey (the "Awardee") at PVWC's Commission Meeting dated July 27, 2022 (PVWC Resolution 22-073) in accordance with the authorized scope of work, and with reimbursement to be on a time-and-materials basis, not to exceed \$175,000.00; and

WHEREAS, PVWC directed Mott to assist the Commission with perform geodatabase upgrades and performing ESRI build for CMMS implementation; and

WHEREAS, it is recommended that PVWC provides Mott with a time extension to December 31, 2023 to allow for continued support while PVWC reevaluates available resources and develops a new contract based on the Commission's needs; and

WHEREAS, Proposed Change Order No. 1 will reimburse Mott for all work projected to be completed up to the new expiration date of said contract and increases the total adjusted Contract Price by an additional \$75,000.00 which brings the total adjusted Contract Price to \$250,000.00; and

WHEREAS, the Director of Engineering has estimated a reasonable cost estimate based on the nature and scope of extending Goods and Services to the new expiration date of said Project and has recommended additional costs related thereto, be approved; and

WHEREAS, the said changes will be incorporated into an Amendment to Agreement for the Project, the form of which is also attached hereto and made a part hereof as Exhibit A; and

WHEREAS, the additional services to be rendered pursuant hereto constitute professional services (or extraordinary unspecifiable services) within the meaning and intent of the Local Public Contracts Law; and

WHEREAS, PVWC's Chief Financial Officer has certified, with respect hereto, that funds are currently available for said purpose and a copy of the said certification is attached hereto and made a part hereof as Exhibit B.

NOW, THEREFORE, BE IT RESOLVED, by Passaic Valley Water Commission, in the County of Passaic, New Jersey;

- 1. That PVWC hereby approves Change Order No. 1 and time extension to the terms as set forth hereinabove; and
- 2. That the appropriate officials of PVWC, and such other officers, employees and officials of PVWC, on behalf of PVWC, are hereby authorized to execute and enter into the said extension to the Agreement, and to perform such other acts and execute such documents as are necessary to implement the terms and intentions of this Resolution; and
- 3. That this matter shall be advertised as required by New Jersey law, in accordance with an appropriate form of notice, and a copy of this Resolution and Agreement shall be placed on file and made available for inspection at the office of the Administrative Secretary of Passaic Valley Water Commission.
