WHEREAS, Project 20-B-19 entitled "Replacement of Air Handling Equipment at LFWTP Laboratory" (the "Project") was awarded to H&S Construction and Mechanical, Inc. ("H&S") of Elizabeth, New Jersey at PVWC's Commission Meeting dated March 10, 2021 (PVWC Resolution 21-32) in accordance with the authorized scope of work, and with reimbursement to be on a time-and-materials basis, not to exceed \$1,674,000.00; and

WHEREAS, Change Order No. 1 was approved and adopted on April 27, 2023 (Resolution # 22-043), authorizing a revision to the Scope of Services; price increase of \$290,430.29 bringing the total adjusted Contract Price to \$1,964,530.29; and a contract extension of three (3) months; and

WHEREAS, it is recommended that PVWC provide the Contractor with a second non-compensatory time extension to the existing contract from October 1, 2022 to December 31, 2023 to provide Contractor the additional time to procure and replace defective HVAC equipment that has malfunctioned;

NOW, THEREFORE, BE IT RESOLVED, by Passaic Valley Water Commission, in the County of Passaic, New Jersey;

- That PVWC hereby approves Change Order No. 2 hereby authorizes a noncompensatory time extension to the terms as set forth hereinabove with a new expiration date of December 31, 2023; and
- 2. That the appropriate officials of PVWC, and such other officers, employees and officials of PVWC, on behalf of PVWC, are hereby authorized to execute and enter into the said Amendment to the Agreement, and to perform such other acts and execute such documents as are necessary to implement the terms and intentions of this Resolution; and

3. That this matter shall be advertised as required by New Jersey law, in accordance with an appropriate form of notice, and a copy of this Resolution and Agreement shall be placed on file and made available for inspection at the office of the Administrative Secretary of Passaic Valley Water Commission.
