WHEREAS, Project 22-Q-12 entitled "Professional Engineering Services for Corrosion

Control and Microbiological Treatment" (the "Project") was awarded to Hazen and Sawyer

("Hazen and Sawyer") of Iselin, New Jersey at PVWC's Commission Meeting dated October

26, 2022 (PVWC Resolution No. 22-107) in accordance with the authorized scope of work,

and with reimbursement to be on a time-and-materials basis, not to exceed \$75,000.00;

and

WHEREAS, at PVWC's request, Hazen and Sawyer has submitted a proposal dated

July 5, 2023 (the "Proposal") to request a budget amendment to assist the Commission with

additional tasks relating to said Project will focus on IT Planning and will include working

with the PVWC IT Department to develop the framework for the Business Intelligence

Dashboard system; and

WHEREAS, a copy of the Proposal, including a detailed description of the said

additional services, is attached hereto and made a part hereof as Exhibit A; and

WHEREAS, Proposed Change Order No. 1 increases the total adjusted Contract Price

by an additional \$50,000.00 which brings the total adjusted Contract Price to \$125,000.00;

and

WHEREAS, the Director of Engineering has reviewed Hazen and Sawyer's Proposal

and found it to be reasonable, considering the nature and scope of additional Work involved,

and has recommended that the said changes to the Project, and additional costs related

thereto, be approved; and

WHEREAS, the said changes will be incorporated into an Amendment to Agreement

for the Project, the form of which is also attached hereto and made a part hereof as Exhibit

B; and

WHEREAS, the additional services to be rendered pursuant hereto constitute

professional services (or extraordinary unspecifiable services) within the meaning and intent

of the Local Public Contracts Law; and

WHEREAS, PVWC's Chief Financial Officer has certified, with respect hereto, that

funds are currently available for said purpose and a copy of the said certification is attached

hereto and made a part hereof as Exhibit C.

**NOW, THEREFORE, BE IT RESOLVED,** by Passaic Valley Water Commission, in the County of Passaic, New Jersey:

- That PVWC hereby approves Change Order No. 1 and awards the changes to the scope of Work for the Project as set forth hereinabove; and
- 2. That the appropriate officials of PVWC, and such other officers, employees and officials of PVWC, on behalf of PVWC, are hereby authorized to execute and enter into the said Amendment to the Agreement, and to perform such other acts and execute such documents as are necessary to implement the terms and intentions of this Resolution; and
- 3. That this matter shall be advertised as required by New Jersey law, in accordance with an appropriate form of notice, and a copy of this Resolution and Agreement shall be placed on file and made available for inspection at the office of the Administrative Secretary of Passaic Valley Water Commission.

Dear Mr. Porcaro,

Hazen is pleased to provide this proposal for Amendment No. 1 to conduct *Phase II – Enterprise Business Intelligence (BI) Dashboard – IT Planning* under Professional Engineering Services for Project No.22-Q-12. Under this Amendment No. 1, Hazen will continue working with IT to set up the Power BI and data warehouse environment.

### Key Activities to be Conducted Under Amendment No. 1:

- Project Management: Hazen will continue to provide project management and contract administrative services throughout this amendment, inclusive of conducting recurring (up to 6) progress meetings.
- IT Requirements: Hazen will conduct meetings with IT staff to understand the IT team's objectives for the BI system, such as improving data governance, enhancing system performance, or streamlining data integration processes. These meetings will focus on gathering IT's specific requirements related to system architecture, data sources, security measures, and scalability to ensure that the proposed solution meets IT's technical needs.
- Initiate Data Discovery: Hazen will conduct an initial data discovery to identify the location and storage platform for each data source (CIS, LIMS, BOSS811, GIS, USGS, and NWS) and identify the appropriate methods and technologies for extracting data from the source. Execution of this task assumes that PVWC provides Hazen team members with remote read access to relevant databases and/or applications.
- Establish a Development Environment and Coordinate Remote Data Access: Hazen will
  work with IT to set up a development environment provisioned with the necessary hardware,
  software, remote access, and permissions to support the development team's needs.
- Initial BI Reporting Database Setup and Data Source Connections: Hazen will initiate the set up of the BI reporting database to store and manage the data for the BI system. Discussion will be had with IT on whether this database will be on-premises versus on in the cloud. Hazen will also work with IT to initiate establishing connections to relevant databases, APIs or web services.

Power BI Tenant Support: Hazen will work with IT to set up the initial PVWC Power BI tenant
configuration, including configuring organization settings, custom branding, and tenant-level
security and compliance policies.

This amendment allocates an additional \$35,800 to complete the IT Planning services through the end of October 2023. A detailed breakdown of the cost by subtasks is provided in the attached spreadsheet.

WHEREAS, the original scope set forth in the PROFESSIONAL'S proposal for the PROJECT is hereby modified as set forth in PROFESSIONAL's proposal dated July 5, 2023, a copy of which is attached hereto and made a part hereof as Exhibit A; and
