## AMENDMENT TO CONTRACT NO. 22-V-18 ENTITLED "POLYALUMINUM CHLORIDE"

WHEREAS, on May 5, 2022, two (2) bids were received by the Passaic Valley Water Commission ("PVWC") for Contract No. 22-V-18, (the "Contract") entitled "Polyaluminum Chloride;" and

WHEREAS, PVWC approved the award of the Contract on May 25, 2022 to USALCO, LLC of Baltimore, Maryland for a period of Seven Hundred and Thirty (730) Days or Two (2) Years; and

WHEREAS, due to significant price increases in the market, USALCO, LLC advised that they were no longer able to supply Polyaluminum Chloride to PVWC at the contract price and requested a price increase to ensure no disruption in the delivery of Polyaluminum Chloride; and

**WHEREAS,** PVWC conducted due diligence and market research with respect to the price of for Polyaluminum Chloride in the market; and

**WHEREAS,** PVWC has determined that it would be fair to raise the contract price from \$1,325.45 per dry ton to \$1,404.85 per dry ton for the remainder of the Contract; and

**WHEREAS,** it is PVWC's intention to go back out to bid in May 2024.

**NOW, THEREFORE, BE IT RESOLVED,** by Passaic Valley Water Commission, in the County of Passaic, New Jersey:

- 1. That PVWC shall agree to a price increase of \$1,325.45 per dry ton to \$1,404.85 per dry ton for the remainder of the Contract.
- 2. That appropriate officials and employees of the PVWC be and are hereby directed to perform such acts and execute such documents as are

necessary to implement the terms and intentions of this Resolution as set forth hereinabove.
