#### Assignment of Contract and Novation Agreement

This Assignment and Novation concerns the Contract awarded on July 14, 2021 (and subsequently renewed on July 14, 2022 and extended to December 31, 2023) related to PVWC Project No. 21-P-40 (the "Contract") (attached as **Exhibit A** hereto) between **Crew Engineers, Inc.** (the "Assigning Party") and **Passaic Valley Water Commission** (the "Remaining Party"), and intends to effect transfer of rights and responsibilities from the Assigning Party to **H2M Associates, Inc.** (the "Receiving Party") (the Assigning Party, Remaining Party, and Receiving Party collectively referred to as the "Parties").

The Remaining Party hereby consents to such transfer and acceptance, releases the Assigning Party from its existing and future obligations under the Contract, releases the Assigning Party from its liabilities for previous performance to the extent such have been accepted by the Receiving Party, and affirms its owing all yet to be performed contractual obligations to the Receiving Party as if the Receiving Party were its original counterparty to the Contract.
