MR. AMODIO: Roll call.

(Roll call was taken, all Commissioners
respond in the affirmative)

MR. AMODIO: Thank you.

The time is 9:42.

You have a quorum.

All of the requirements of the Open Public Meetings Act have been met. Commission meeting notice have been furnished to all Commissioners, city clerks of Paterson, Passaic, and Clifton, North Jersey Herald News, The Record Passaic County edition and the Commission's executive staff with a copy posted on the main bulletin board at the Clifton facility.

Please rise. Commissioner DeVita, would you please lead us in the Pledge of Allegiance?

Commissioners, there's a member of the public that would like to address you. If you would like to start with him.

PRESIDENT SANCHEZ: Sir, can you state who you are, for the record?

MR. SEXTON: My name is Avi Sexton.

PRESIDENT SANCHEZ: You live where?

MR. SEXTON: I live in Clifton but my issue is about Paterson. I'm a landlord in Paterson.

PRESIDENT SANCHEZ: What can we do for you?

MR. SEXTON: The issue in Paterson is as follows. I have a commercial unit that I rent out and I've had a tenant over there for a couple of months. The bill's under the tenant's name and the tenant was evicted because they weren't paying the rent for us -- they weren't paying our rent

and for some reason they were also not paying Passaic Valley Water Commission. So we were left with the bill, yet, we have two other units upstairs that we pay the bill for. These are residential units. We didn't get any kind of notice to the landlord's address and I'm not sure why Passaic Valley Water doesn't really have the landlord's address regarding a shutoff.

We suddenly had a shutoff out of nowhere. And I'm not complaining so much about the restaurant, because I understand that Passaic Valley Water has to bill us for that restaurant, but we'll talk about that in a moment. But now the tenants upstairs, which we were paying the

bill for all along, had no water. We got no notice of the shutoff. And they had no water. Maybe some notice was posted --

PRESIDENT SANCHEZ: Hold on. Let me stop you. I have one question. It's only one meter for the whole building?

MR. SEXTON: No. There's actually two meters. There's one meter for the restaurant and one meter for the tenants upstairs.

PRESIDENT SANCHEZ: What you're saying is that the commercial wasn't paying, but the upstairs was paying water?

MR. SEXTON: Yes.

COMMISSIONER RODRIGUEZ: What is the address in Paterson?

MR. SEXTON: 444 Broadway.

PRESIDENT SANCHEZ: Do you know anything?

MR. KELLY: First I heard of it just now.

PRESIDENT SANCHEZ: Anything you know,
Joe?

MR. BELLA: This is the first I heard.

PRESIDENT SANCHEZ: Can we do one thing?
Can you walk out with that gentleman. Let's find
out what happened, whether they made a mistake and
then once that's done, he's going to come back and

tell us what happened.

COMMISSIONER BAZIAN: One question. Is
the water on right now?

MR. SEXTON: The water's on right now and
it took us an arm and leg to get that open. We
had to pay literally half the bill of the
restaurant so we can get the water open when, yet,
the restaurant wasn't really our bill but that's
up for discussion. I understand that that could
be a debate whether or not the landlord is
responsible or not for the restaurant's bill.

PRESIDENT SANCHEZ: No, no, let me get one
thing clear out of the way so you know. You're
the landlord?

MR. SEXTON: I am the landlord, yes.

PRESIDENT SANCHEZ: You are responsible
for the water, whether -- it goes against the
property, against the landlord. It doesn't go
against the tenants. Let me tell you that.

You should have some escrow money in the

future so when people move out, so, if that's not the case, you are responsible for the water.

MR. SEXTON: well, if that's the case, if I'm responsible, my only request from Passaic Valley is whenever a tenant opens an account, they

should always have the landlord's address so any kind of notices of either accumulating balance or a shutoff notice, we would be notified of that.

COMMISSIONER BAZIAN: Is there a notice posted on the board?

MR. SEXTON: I didn't see any notice and the tenants didn't get any notice. So as far as I know, there was no notice.

COMMISSIONER BAZIAN: whose name is --

MR. SEXTON: It was always billed under the tenant.

COMMISSIONER DeVITA: Mailed to the tenant?

MR. SEXTON: And always mailed to the tenant.

COMMISSIONER DeVITA: And there's two apartments upstairs?

MR. SEXTON: Correct.

COMMISSIONER KOLODZIEJ: I don't know the City of Paterson, but in Clifton, when a tenant moves out, the landlord is required to tell the city who the --

MR. SEXTON: We have a CO.

COMMISSIONER KOLODZIEJ: what I'm trying

to say here is why would you not ask the water

Commission, since they're your tenants, you want them to pay their water, which other landlords obviously eat, why would you not be responsible for saying you want a duplicate bill? You're the landlord. You're watching your tenants. Not that I'm saying you're wrong, but I'm saying there might be a couple of ways to handle this.

Every time you get a new tenant and you're going to tell them they have to pay the water, then you should notify us saying you want a copy of that bill sent to you.

MR. SEXTON: That's pretty much what we want.

COMMISSIONER KOLODZIEJ: Exactly. There's a couple of ways.

MR. SEXTON: That could be done?

COMMISSIONER KOLODZIEJ: Oh, absolutely.

MR. SEXTON: We weren't aware of that.

COMMISSIONER KOLODZIEJ: What do you need now in the way of relief? Just the guarantee that it won't happen again?

MR. SEXTON: And also the fact that my tenants went over two days without water.

COMMISSIONER KOLODZIEJ: Well, we're going to get an answer as to how that happened.

MR. SEXTON: All these fees for my tenants to get the water when the restaurant --

COMMISSIONER RODRIGUEZ: If you have two separate meters, my question is, if you have two separate meters, why did they have turn off the meters --

MR. SEXTON: When I called there, I believe they said there's only one shutoff valve, which that's really unfair.

PRESIDENT SANCHEZ: Did they go to the meter?

MR. KELLY: No, what happens is, when a landlord takes out the property, there's one valve at the curb. It's his option to tell us to put two in. He has to pay for it. Because he's renting commercial property.

PRESIDENT SANCHEZ: It's still unfair to shut off people that's been paying. We as an industry should do it because, I mean...

COMMISSIONER RODRIGUEZ: We can ask the landlord do they want to put two separate, we can't take on that responsibility, without -- let me --

MR. KELLY: We need access to the basement.

COMMISSIONER RODRIGUEZ: I'm saying, if there's one shutoff valve, it's up to the landlord. And this is food for thought for the future, if you're going to continue to rent a commercial space, that is something that's an investment you might want to make on your

property, because you don't know what the turnaround is. I don't know how long you've been the landlord. I don't know what your turnaround is there in that specific area of Paterson, 444 Broadway. So that's something you may want to consider for the future as well as an escrow, but also something that way your tenants are not penalized.

MR. SEXTON: Yes, but even if we do have one shutoff valve and two meters, at least the paying meter should get some kind of notice and why should the paying meter --

COMMISSIONER RODRIGUEZ: Because there's two separate bills.

PRESIDENT SANCHEZ: Let me --

COMMISSIONER DEVITA: Can I make a suggestion? Let him go talk to John.

PRESIDENT SANCHEZ: John, if there's something that we could do, let us know, please.

MR. AMODIO: Pursuant to the Open Public Meetings Act, Commissioner Bazian offers the following Resolution for adoption:

whereas, Section 8 of the Open Public Meetings Act permits the exclusion of the public from meeting in certain circumstances; and.

whereas, the public body is of the opinion that such circumstances presently exist;

Now, therefore, be it resolved, by the

Commissioners of Passaic Valley Water Commission:

1. The public shall be excluded from discussion in the hereinafter specified subject matters; the general nature of the subject matters being: Financial, Insurance, Personnel, Contracts, Negotiations, Security, Miscellaneous Litigation. North Arlington v. PVWC. In the matter 286 Terhune Avenue, Passaic. Delford Gardens v PVWC. Four Seasons request for expanded use of ingress/egress. Commissioner conflict of interest-appointments. Summary/aging. we have 75 Franklin Ave. and Lodi v PVWC.

MR. HANLEY: And also Joe advises me that they want to report on filters.

MR. AMODIO: And a report on filters.

Personnel: New hires, Mike Ciolino, Richard Gullick, Christopher Nikodem. And also we have a report on department head salaries to be passed out.

Under Administration we have excess liability coverage. Paterson MUA request for water bill adjustment. Proposed consolidation for merger North Jersey District Water Commission and New Jersey Water Supply.

2. It is anticipated at this time that

the above-stated subject matter will be ratified during public meeting following or as soon thereafter as the reason for the discussion no

3. This Resolution shall take effect immediately.

Second by Commissioner Vannoy.

On the roll.

(Roll call was taken, all Commissioners respond in the affirmative)

MR. AMODIO: The time is 11:19.

You have a quorum.

We will go to the Executive Director's report.

MR. BELLA: I just wanted to get you up to speed what's going on with the distribution system. As I said, back in the summer, we're experiencing an increase in main breaks because of that, because of the big main break. This is the time of year when you see it.

We've done wonderful. Our people have

done a wonderful job keeping up with it. It's really -- we're straining our resource, 11 more breaks in December than we normally had. It's a big jump. It's like a 30 percent increase, 40 percent increase.

COMMISSIONER BAZIAN: What's that attributed to?

MR. BELLA: I believe, for one thing, we had pretty cold weather, but when it gets cold and stays cold, it generally, your main break rate goes down. And it turned cold very fast, so that increased.

The other thing is that, remember we had that depressurization of a portion of the system because of the big main break. I believe that the defects that you would see from the depressurization will show up for over -- for about a year or so you will see the increase in the main breaks. And in fact, we've seen increased main breaks in that area. So that will continue.

Jim reported about the filters.

Generally, the plant is working very well. Everything is going well under these circumstances. It's usually pretty hard,

especially when you get a lot of salt runoff that could interfere with your process.

And generally, that's pretty much it.

PRESIDENT DeVITA: So the water is still running through the pipes?

MR. BELLA: Yes, it is.

PRESIDENT DeVITA: Anybody have any questions of Joe?

Next.

MR. AMODIO: Okay. Next we have requests from former Commissioner Ken Hayden, City of Paterson, a request PVWC to replace a stolen

plaque at the Great Falls Walk Over Bridge which was dedicated to Frank F. Graves, Sr. This was carried from the December meeting.

PRESIDENT DeVITA: Can I ask a question? Was this our plaque?

MR. BELLA: Yes.

PRESIDENT DeVITA: We --

MR. BELLA: I think it was in '82.

PRESIDENT DeVITA: This was Sr., Frank Graves, Sr.?

MR. BELLA: It had to do with the arch bridge and that pedestrian bridge which we own. Apparently, it is all dedicated. There was a

plaque put there. And I don't think it lasted more than a few months, actually.

PRESIDENT DeVITA: So it's been gone since the '80s?

MR. BELLA: As far as I can tell. I never actually seen the plaque. There's a place in the rock.

COMMISSIONER KOLODZIEJ: It's a tough situation because with the vandalism and I can vouch for that by one the parks that we had renovated. We went for this wonderful restoration and, again, the ability to steal these things are there. So even if we replace this, there's no guarantee, you know, I'm saying to myself, unless there's some kind of insurance you have, but you can't.

So, you know, unfortunately there's got to be some other way to acknowledge this.

MR. BELLA: One way to do it just have a rock and have somebody come out and carve.

COMMISSIONER KOLODZIEJ: It doesn't work out.

PRESIDENT DEVITA: You mean etch into the rock?

COMMISSIONER RODRIGUEZ: How much does

that cost?

COMMISSIONER KOLODZIEJ: It's no guarantee that in two years, six months we're going to be right back here.

COMMISSIONER RODRIGUEZ: I understand all the sentimentality of it but, you know.

COMMISSIONER SANCHEZ: You know what, this is what my proposal is. Do it ASAP.

COMMISSIONER RODRIGUEZ: Tell them.

COMMISSIONER KOLODZIEJ: Do what ASAP?

COMMISSIONER RODRIGUEZ: Tell him no.

PRESIDENT DEVITA: What's the consensus?

COMMISSIONER SANCHEZ: We're not going to do it.

PRESIDENT DEVITA: Was this a bronze plaque?

COMMISSIONER LEVINE: How much does a plaque like that cost?

MR. BELLA: A lot. At least a couple of thousand dollars.

COMMISSIONER LEVINE: Let's do something

cheap, less expensive.

COMMISSIONER KOLODZIEJ: There's a whole initiative going on there. Can't we wait?

COMMISSIONER LEVINE: Come up with some

ideas less expensive and propose to the Board. We gave it to him in '82. He deserves it. There's got to be something more cost effective.

PRESIDENT DeVITA: Maybe there's some alternatives.

COMMISSIONER RODRIGUEZ: That's expensive.

COMMISSIONER KOLODZIEJ: It's coming back to us.

PRESIDENT DeVITA: So that will be tabled until Joe comes back to us next meeting. You'll have something at the next meeting?

MR. BELLA: Yes, I will.

PRESIDENT DeVITA: Thank you.

Next, Louis.

MR. AMODIO: Yes, Passaic County Police Academy request use of Point View Reservoir.

COMMISSIONER KOLODZIEJ: So moved.

COMMISSIONER RODRIGUEZ: Second.

MR. AMODIO: On the roll.

(Roll call was taken, all Commissioners respond in the affirmative)

MR. AMODIO: Motion approved.

Thank you.

The Controller is not here. Joe, I believe he gave you a narrative.

MR. BELLA: I had him put a narrative in my actual report. He'll be back.

PRESIDENT DEVITA: In your report?

MR. BELLA: Yes.

MR. AMODIO: Okay. Next we have Resolutions.

The first one will be Resolution establishing meeting dates and times for the year 2011.

PRESIDENT DEVITA: Does anybody have a problem with the third wednesday? I got an issue with one month, but I think Commissioner Vannoy may, too, in March. I don't have a problem with the third wednesday at 9:30. would it be possible to move the one in March? Move the one meeting in March --

COMMISSIONER LEVINE: The fourth doesn't work. Let's do it the Tuesday then.

MR. HANLEY: There's a fifth.

PRESIDENT DEVITA: Let's do it the fifth.

COMMISSIONER RODRIGUEZ: I won't be here, the 30th.
