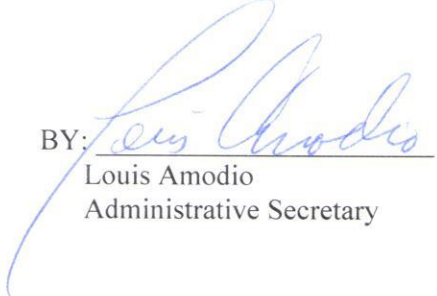
NOTICE OF REORGANIZATION AND REGULAR PUBLIC MEETING
